Additional funding/ Pupil Premium Funding

As you know, we are focused on providing the best possible education for the children across The Moorlands Primary Federation.

Healthy meals in school are important to a child as they can not only support children on a daily basis with their wellbeing and readiness to learn, but also help them establish healthy habits for life. School meals are, of course, available to all children in school.

Registering for 'Free School Meals' could also secure extra funding for your child's primary school to go towards valuable support like additional learning support or funding towards educational visits or activities for your child. Although children in Reception and Key Stage 1 are all automatically eligible to receive free school meals, parents are still able to (and encouraged to) apply for Free School Meals, as this funding and the associated benefits are also available to children in these age groups too (and does not impact on children's eligibility to receive free school meals).

This additional money is made available to schools from the Government for every child whose parent is receiving one of the benefits listed below:

Families who receive certain benefits may be eligible for Free School Meals and Pupil Premium Funding. Your child is eligible if you're in receipt of one of the following benefits:

- Universal Credit with an annual net earned income of no more than £7,400;
- Income Support;
- Income-based Jobseeker's Allowance;
- Income-related Employment and Support Allowance;
- Support under Part 6 of the Immigration and Asylum Act 1999;
- The guarantee element of Pension Credit;
- Working Tax Credit run-on (paid for the four weeks after you stop qualifying for Working Tax Credit);
- Child Tax Credit (with no Working Tax Credit) with an annual income of no more than £16,190.
